35/2025 Grants and Community

Longfield Hill Trees: Cllr. Tamber enquired on the current progress. Cllr. Smith confirmed site meeting at Longfield Hill with residents went ahead and previously agreed actions have been completed and residents advised. Currently waiting on sign off from Dartford Borough Council before works can be completed.

Clerk advised that after speaking with approved supplier of works, the suggested ongoing inspection (potential maintenance recommendations) should be on a bi-annual basis. Approved by all present. **Action: Clerk to diarise next inspection date after completion of works.**

Long Valley Hall: Increase of 3% costs by PHS was noted by all present. Cllr MacDonald enquired if there should be a bin in the men's toilets. It was advised bins were available in ladies and disable/baby change toilets.

Request for regular hire from Little Longfield toddler group was received with a requirement for storage and a potential for a reduced hire rate as a voluntary community group. After discussion, the Parish Council agreed they would like to be able to support such a group and it was agreed the reduced hire rate could be offered after a six-month period, but that storage is, and would be, an issue. All current cupboards are full and there is no available free space either outdoor or internally for any further storage. Agreed by all present.

Action: Clerk to respond without outcome to request.

Request from local U9's football group to train and play matches at Long Valley field area. After discussion it was agreed that capacity was currently fully utilised by Longfield Tigers. Alternative suggestion offered was Longfield Academy. Agreed by all present.

Action: Clerk to respond with outcome to request.

Play Areas:

Completion of repairs to Billabong Park and MUGA noted by all present and invoice approved for payment to Playfix £4714.80. Proposed Cllr. Brown, seconded Cllr. Kite.

Cllr. Kite advised there may potentially be a budget amount remaining from Dartford Borough Council's park refurbishment project for leased play areas (Billabong Park, Long Valley Hall). This may enable potential for equipment upgrades. The Project Manager would be in contact with the Parish and outline what would be suitable/available.

Cllr. Smith commented on the high cost of play equipment repairs and thought it was worthy of sharing to the community via publication in the Chairman's annual report.

Parish Community Event 2025: Agreed to proceed with one cinema in the park event August/September 2025. Agreed by all present.

Action: Clerk to contact supplier with availability of dates and films.

36/2025 Kent Association of Local Councils: Cllr MacDonald shared update from the recently attended meeting explaining discussions were around plans for devolution and information gathering.

37/2025 Borough and Parish Councils Forum: Next meeting postponed due to upcoming elections. Cllr. Brown provided update from the last meeting around current devolution plans.

38/2025 Dartford Borough Council: Cllr. Kite advised discussions were ongoing across Kent regarding LGR (Local Government Review). The schedule of summer events was planned and £100 food vouchers to support street parties for VE Day were available via the Dartford Borough Council website.

39/2025 Kent County Council: KCC were in the purdah period with closure date for nominations being 31st March 2025. (Election 1st May 2025).
